Pre-Health Advisors Are...



Faculty Advisors

Though less common these days, the faculty advisor is often a science faculty (HS, CC, Undergrad, Postbac)



Career Advisors

The career advisor is often hired by institutions to serve in "centers" and are often business specialists



Independent Advisors


Often prior institutional advisors
who have left positions and
continue to advise (sometimes
contracted)



Recruiters

Program recruiters from health professions institutions







Support

The advisor is a mentor to students throughout the medical school application timeline by regularly tracking progress, overcoming obstacles, and ensuring strong applications. If needed, they continue supporting students by helping them reevaluate options, manage course loads, gain more experience, and reapply stronger.





Navigating The Landscape





Advisor: Student Ratio

- At many larger universities, there are often designated pre-health/pre-med advisors or teams who work specifically with students interested in pursuing careers in healthcare. The advisor-to-student ratio can vary from 1 advisor per 50-100+ students at these schools.
- Smaller colleges may not have dedicated pre-health advisors. In these cases, general academic/faculty advisors may also assist students with pre-health planning and preparation. The ratios are harder to estimate as advising is mixed with other responsibilities.
- According to one survey* of pre-health advisors, the average caseload was around 90 students per advisor. However, there was significant variability, with some advisors working with as many as 300+ students.
- Averages likely fall somewhere in the range of 1 prehealth advisor per 50 to 150 undergraduate students interested in healthcare careers at many universities.

Advising Trends

- Specifically at smaller institutions, and community colleges, budgets impacted have (in some cases) removed pre-health advising services including alumni and/or Postbac advising.
- These impacts have driven the rise of faculty advisors (many who planned to retire) becoming independent advisors.
- Business model trends in independent advisors have shifted to contract advising with colleges and universities. Which is more cost-effective for institutions than hiring full-time faculty.
- Increased demand and competition More students are interested in pursuing pre-health paths like medical school, leading to higher advisor caseloads and increased competition for limited spots.
- Technology utilization Advisors are using more tech tools like Handshake, Salesforce, and Slack to track students and manage advising. Virtual advising also increased during COVID.
- Earlier intervention There are efforts to engage students in pre-health planning and advising in high school & earlier in college, starting freshman year.





Advising Trends (con't)

- Application support Pre-health advisors are providing more direct application assistance, like personal statement writing support and mock interviews. This requires more advisor bandwidth.
- Training standardization Efforts to standardize pre-health advisor training and define core competencies are increasing through groups like NAAHP. More degree programs specifically for advising exist.
 - Master's in Higher Education Administration Many programs offer concentrations or specializations in academic advising, student services, or college counseling. Coursework covers topics like student development theory, higher education policy, counseling skills, and more.
 - Master's in College Student Personnel Designed to prepare graduates for roles in student affairs and services, including academic and career advising. Field experiences are a key component.
 - Certificate in Academic Advising Some colleges offer post-baccalaureate certificate programs in academic advising for those who want specialized training, often geared towards new advisors.
 - O PhD in Higher Education At the doctoral level, students can choose a concentration in counseling/advising for roles as administrators and advising directors at colleges and universities.
 - Dual Degree Programs Some institutions offer dual programs that combine a master's in higher education with an MBA or law degree for those interested in university administration broadly.

Challenges: Advisor

- Every program has varied requirements
- Finding requirement changes annually
- Access to timely student results (Multiple, but incomplete resources)
- Navigation of over twenty health professions
- Clear guidance for underrepresented or case exceptions (undocumented)
- Clear guidance on experimental requirements (SJTs)
- Need for advocacy for pre-health advisors

Data-Driven Advising

Leveraging Application Data

Review school-specific acceptance data

- Analyze rates for own institution vs. national averages
- Identify strengths/weaknesses in applicant pools

Track application completion metrics

- Evaluate trends in applying vs. matriculating
- Assess barriers causing drop-off at each stage

Identify most commonly selected health programs

- Tailor advising to popular target schools
- Adjust for changes in student interests over time

Correlate admissions with advising received

- Connect application outcomes to advising usage
- Demonstrate impact of advisor interventions

Inform training and resources

- Address any advisor knowledge gaps
- Provide more support in challenging areas





Data-Driven Advising

Improving Advisor Efficiency

Identify application bottlenecks

- Review submitted vs. completed metrics
- Guide students struggling with components

Automate follow-ups on deadlines

- Use portal to track upcoming due dates
- Send automatic reminders to students

Facilitate school comparisons

- Pull accepted student data for multiple programs
- Help students weigh options objectively

Enable targeted interventions

- Identify at-risk applicants using analytics
- Provide focused support to get them on track
